

APPLICATION FOR TRAVEL FUNDING

This form is an application for up to \$5,000 in travel funding from the North Carolina Youth Outdoor Engagement Commission. Per statute, travel funding is capped at \$5,000 per county, per year.

HOW LONG IS THE APPLICATION PROCESS?

Applications are accepted on a rolling basis throughout the year. Annual funds are limited, so we encourage applicants to submit their completed applications as soon as possible.

As participation in competitive events e.g., tournament finals, can often be short notice please contact our staff if you are concerned about receiving funding in time for your event.

Is your organization eligible?

In order to be eligible your organization must be a North Carolina city/county government unit, K-12 school (public, private, or charter), or a registered 501(c)(3) nonprofit whose mission and values align with our own.

Important note for two organizations applying in partnership:

This application form must be signed by both organizations. The financial contact signature should represent the organization that will receive the funds.

Grant funds will be disbursed within 45 days of your event date.

If you will need to make deposits prior to that date, please indicate this in your application. Please note that we cannot provide additional funds to an existing grant once it has been awarded.

Have you attached cost evidence?

If you can provide quotes for travel expenses, submit those with your application.

Have you attached a completed Sub-W9 to your application?

Not to be confused with a W9. We require a Sub-W9 in order to pay out funds to grantees. If your organization/school has received a grant from us in the past two years, you do not need to attach your Sub W-9.

Do you understand that if your application changes, you must submit an Amendment Form?

Any alteration, before or after funding, such as a change in project timeline, location, equipment, or point of contact must be detailed on an Amendment Form and submitted to us for approval prior to funding being spent. Do you understand that unused funds must be returned to us?

Contact us or go to www.GoOutside@nc.gov to learn how to return unspent funds.

Do you understand that unapproved or improper use of funds may result in you being required to return the full grant award? Improper spending includes deviations from an approved grant application, or spending of funds prior to approval of an Amendment Form. Review our guidelines to learn more.
