- 3) Mandatory Ethics Inquiry At the request of Chairman Dell Murphy, Megan Law, Communications Manager, read the mandatory ethics inquiry as stated in GS 138A-15(e).
- 4) Approval Of Minutes Commissioner Mikey Fulk moved that the meeting minutes from August 1<sup>st</sup>, 2024 be approved as written in the exhibit and Commissioner Kevin Howell seconded the motion. The Commission unanimously approved the minutes. (EXHIBIT A)

- 5) Trailblazers Club Report Alan Pomeroy, Program Director, and Noel Griffin, Outreach and Engagement Manager, announced the progress made by clubs throughout the state in the early months of the 24-25 school year. They made Commissioners aware of some trips and educational outdoor outings that clubs had taken in recent months. A testimonial from a student at Thomas Jefferson Classical Academy (Rutherford County) was also shared. The student claimed her involvement and experiences with her school's Trailblazers Club had helped prepare her for the aftermath of Hurricane Helene.
- 6) Patch Program Report Noel Griffin shared updated 2024 Patch Leaderboard standings and noted the increase in patches earned in 2024 compared to 2023.
- 7) Trust Fund Report Layne Randolph, Fundraising and Finance Manager, informed the Commission of updates to the donation totals, both monthly and yearly.
- 8) Youth Sports Grants Alan Pomeroy relayed to Commissioners the number of Youth Sports Grants applications received and approved so far in Fiscal Year 24-25. He also informed the Commission of the ways in which the Youth Sports Grants have been advertised to the public- through a mailer, e-mail and social media blasts, and direct communication with school teachers and administrators. Several Youth Sports Grants recipients and their plans to utilize funding were shared during the meeting, highlighting both travel and host opportunities awarded to public and private schools and non-profits throughout the North Carolina.
